BERTH APPLICATION PROCEDURES AND POLICIES Effective January 1, 2018

Procedures:

Application for monthly rental **must be accompanied by the following:**

- A copy of the current California DMV registration, USCG documentation or “Running Letter” for documentation, in the name of the applicant.
- Proof of watercraft liability insurance in the amount of \$ 300,000.00 in the name of the applicant and Coyote Point Marina listed as “Additional Insured”. Policy applications are not acceptable.
- Proof of land residency (lease / rental agreement, utility bill, etc.) P.O. Boxes do not qualify.
- Copy of California Driver’s License or California I.D. and vehicle registration.
- Recent photograph of vessel.
- A survey less than 1 year old showing that the vessel is in sound condition must be provided for boats with wooden or ferrocement hulls or any vessel 30 years old or older.

Please note that vessels are considered visitors and charged the current visitor rate of \$.50 per foot per night until all of the above requirements have been received and the application and contract are approved by the Harbormaster.

Rules, Regulations & Policies:

- Berth fees will be applied from the date the applicant accepts a berth. Berth fees are due and payable on the 1st of each month. If payment is not postmarked or received by the 25th of the month, a late fee of 10% will be applied.
- **Liveaboards are not allowed.** Tenants may spend a maximum of 3 nights per week aboard.
- A land residence must be maintained during the duration of the lease.
- Vehicles may not be stored or parked in the Marina longer than 3 nights per week, unless authorized by the Harbormaster.
- Vessels shall not be used for commercial purposes (charter, rental, Air B&B etc).

- Guest / Visitor Berthing: \$.525 per foot per night. (Maximum 10 day limit)
- Key / Card Charge: Gate Keys: \$ 3.00 each. Gate Arm Cards: \$ 10.00 each.
- The berth assigned to an applicant and rate charged will depend on the total length of the vessel, including dinghies, anchors, swim platforms, etc., protruding over the bow or stern of the vessel.
- Termination of a berthing agreement by a tenant requires written 30-days advance notice.
